- Includes an aggregate of 17,439 RSUs, which represent the right to receive ordinary shares, par value \$0.000115 per share, of the Issuer, subject to the satisfaction of vesting requirements, and 1,140.7678 shares under the Issuer's Employee Stock Purchase Plan.
- The shares underlying the option will vest as to 33% on each of the first and second anniversaries of the grant date and as to 34% on the third anniversary of the grant date.
